1) Applicants must ensure that they satisfy all entry requirements before applying for the course. Payment **MUST** be done within **3 working days** after registration. Once the Candidate exceeds the given timeline, the seat will be released for new booking.

2) Your reservation is valid for only **3 DAYS** from the date of reservation **OR** before Class Start Date, whichever is earlier. If you do not make the required payment by the Pay-By Date, CUTTECH reserves the right to allocate your seat to other trainees without prior notice. **All listed Fees are subject to GST (Goods and Services Tax) applicable on the original course & full course fee, prior to any funding.**

3) Trainee shall be bound by the Terms and Conditions of any applicable funding scheme as approved by CUTTECH. Funded candidates may be permitted to pay upfront only a portion of the course fee (less the potential amount) at the point of application.
